

# Documents, Volume 6: February 1838–August 1839 Is Now Available

In September, the Joseph Smith Papers published <u>Documents, Volume 6: February 1838–August 1839</u>. This volume—containing documents such as letters, minutes of meetings, revelations, land transaction records, and accounts of discourses—illuminates one of the most difficult periods of Joseph Smith's life and for the Latter-day Saints at large. *Documents, Volume 6,* traces this pivotal period in church history that includes the "Mormon War" in Missouri, the expulsion of the Latter-day Saints from the state, Joseph Smith's time in Liberty jail, and the initial settlement of the Nauvoo, Illinois, area. <u>Read more</u> ▶
